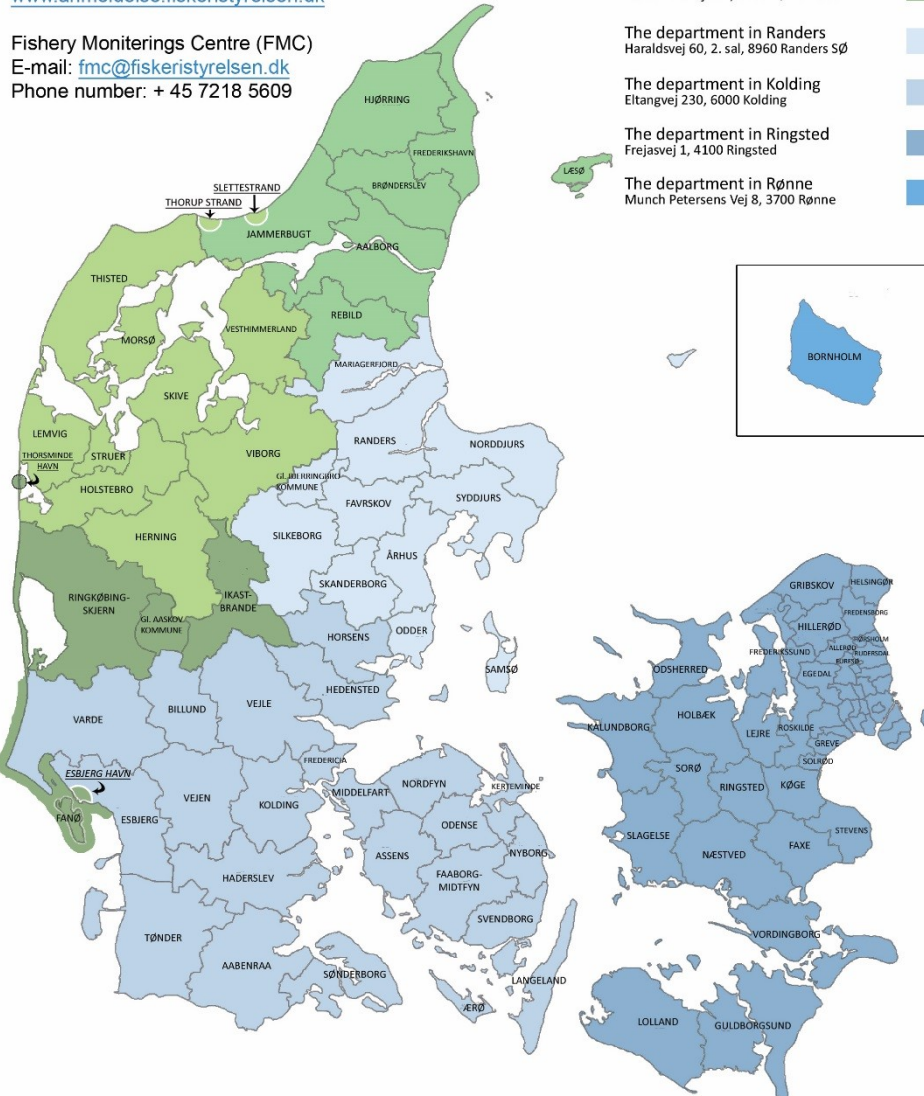

Updated January 2024

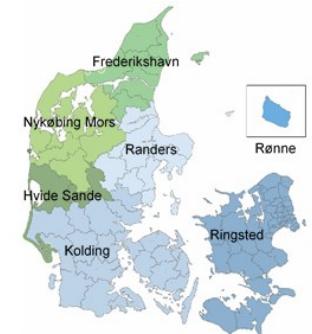


Catch limits for cod and salmon in the Western Baltic. Valid for angling in 2024.

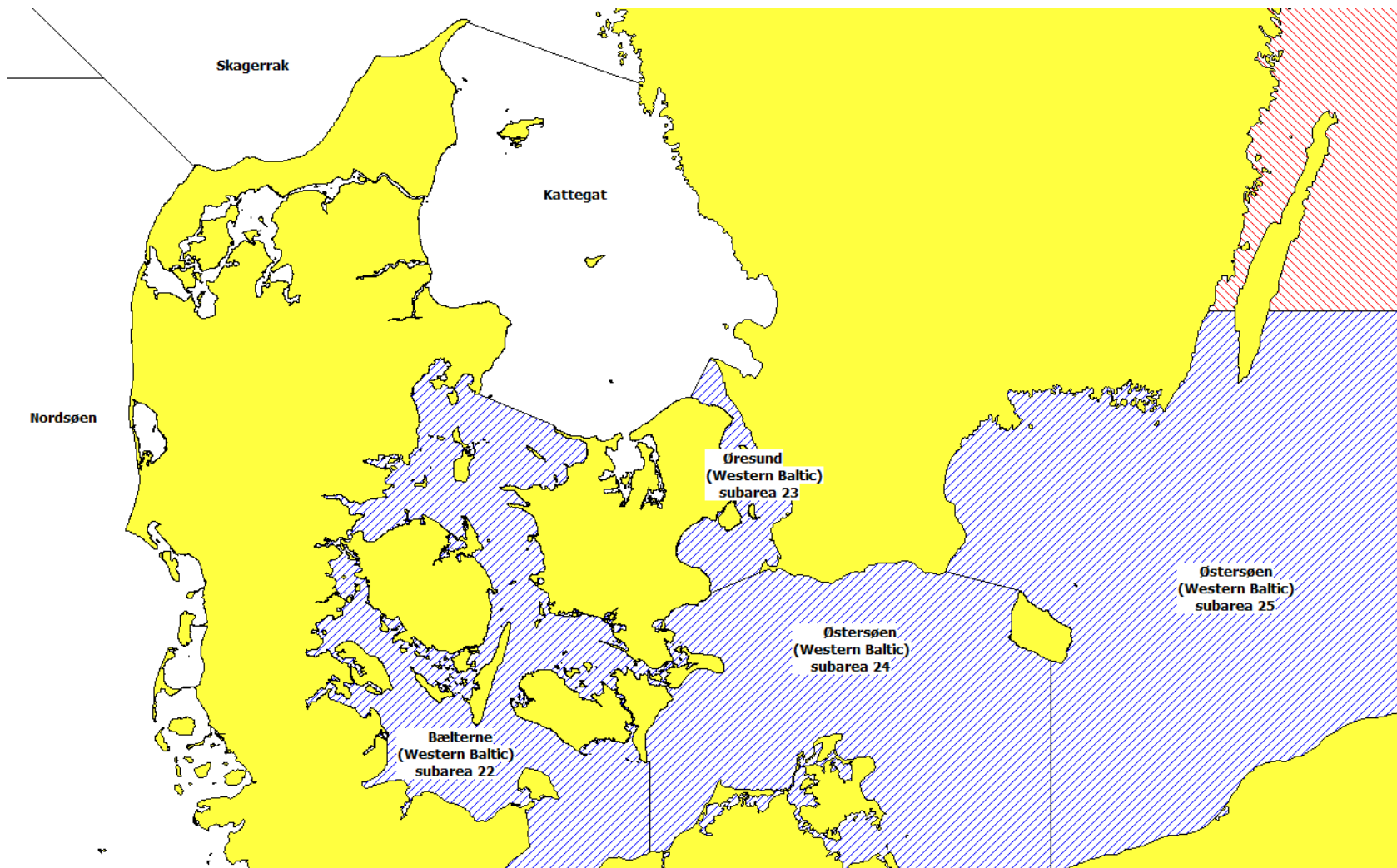
# Restrictions on cod and salmon fishing for anglers in 2024

## Cod.

In blue area: Fishing for Cod is prohibited all year round in subarea 22, 23, 24, 25 and 26.<sup>1</sup>

## Salmon

In both the colored areas (blue and red), any salmon caught shall be immediately released back into the sea. However, one specimen of adipose fin-clipped salmon may be retained per angler per day. Salmon retained shall be landed whole.<sup>2</sup>



### Note!

The rules also apply if you go angling from a tourboat.

During angling for salmon, all fish caught shall be landed whole.
